With that understanding, I/we agree to indemnify, defend, and hold harmless Mallard Trap Club, its officers, members and agents, from and against any and all claims, liens, injuries, suites, or judgements arising from, or in connection with, my/our presence on Mallard Trap Club property. I/We agree to this indemnification and hold harmless for myself/ourselves, my/our successors, assigns, heirs, executors and administrators, and any other person or entity(ies) who/which may have a claim based upon my/our personal injuries and/or property damage.
